# Chair's report to the Members of the Art Deco Trust Inc. for the year ended 31 August 2025

It is my pleasure to report on the activities of the Art Deco Trust Inc over the past 12 months.

## **Highlights**

Launching our 2025 Art Deco Festival Napier programme was the first major milestone of the year in October 2024, as we eagerly anticipated a balmy Hawke's Bay Summer and a return to business-as-usual full scale Festival programme! The weekend celebrations didn't disappoint

In November the Trust hosted the 2<sup>nd</sup> edition of the Hawke's Bay Heritage Awards, in collaboration with Napier City Council and Hastings District Council at the Napier War Memorial Centre.

Also, in November at our AGM we awarded Life Membership of the Trust to Corinne Bowey and Dean Hagen and acknowledged John Cocking (already a life member) for his 30 years' service to the Trust.

The Trust experienced a very busy summer of tourism activity welcoming over 16,000+ visitors to our shop, on walks, on coaches and in our vintage cars.

The Festival in February was another highlight hugely successful and economically provided over \$2.5m net benefit into the local economy.

May provided us with our annual opportunity to thank all our volunteers and issue long service certificates for 5-, 10-, 15-, 20-, 25-, and 30-years' service to the Trust. This year we acknowledged Tony Chittenden and Sue Myles as members of the Trust's 30-years of service club.

In July, and perhaps one of the most significant events the Trust has been involved with for many years, saw the completion the long-planned move from 7 Tennyson Street to our new home, the newly restored (former) Women's Rest Building, in Memorial Square. This project was a huge undertaking for the Trust in partnership with Napier City Council – the restoration took 10-months to complete, and we are extremely grateful to everyone involved in the project.

# Our Activities Heritage

A very important part of the Trust's work is the administration of the Robert McGregor Heritage Fund (RMHF), which this year has provided six (6) grants to various Napier CBD building owners. This year's grants were awarded to the following buildings for repair and repainting projects:

- (former) Empire Hotel, 1 Shakespeare Road;
- Mackenzie House, 24 Hastings Street;
- Focal House, 109 Clive Square West;
- Briasco Building, 162 Emerson Street;
- Smith and Chambers Building, 122-132 Emerson Street; and
- (former) Bank of New Zealand, Emerson and Tennyson Street

Awards given for Napier CBD art deco era building minor repairs and façade painting. Decision making as part of the awards programme is made by members of the Heritage Working Group – Ann Galloway, Guy Marriage, Matthew Bonnett, Napier City Councillor Ronda Chrystal – who has been joined by Napier City Council Planning team member Minnie Fox, who replaces long standing Working Group members Napier City Council Senior Policy Planner Fleur Lincoln. Also stepping down this year from the Working Group was David Low and Hastings District Councillor Michael Fowler. I sincerely thank current and past members for their roles guiding the city of Napier's heritage precinct.

Since inception, the Fund has distributed/committed to is over \$190,000 in grants to building owners, supporting nearly 40 different projects. The RMHF is an initiative we undertake with Napier City Council, and the Trust is actively fundraising to increase our annual disbursement through the Fund.

Other heritage activity during the year included our continued partnership with Historic Places Hawke's Bay, with the Trust presenting our third half-hour, heritage-focused speakers' lunchtime talks at 7 Tennyson Street. These events were extremely well attended, and we look forward to continuing this partnership in the future in our new location in Memorial Square.

Presented biannually, the Hawke's Bay Heritage Awards are the region's communities' opportunity to recognise and celebrate the individuals, groups and organisation from across the region whose talents and energies preserve our cultural heritage and inspire us to connect with our past, so that we can all feel more confident in our future. This edition saw Te Kura i Awarua Rangahau Māori Centre, Eastern Institute of Technology (EIT) awarded the Supreme Winner, acknowledging their work across a number of 'heritage projects' including the Henare Matua collection of Repudiation Movement letters of the 1870s, the JT Blake manuscripts of the 1880-90s and the raising of two Heritage Symposiums bringing archivists and curators nationally to Hawke's Bay. The team have also been involved in the Te Po-ho o-Kahungunu carvings repatriation, bringing them to Hastings for the 2023 Symposium.

#### Walks&Tours

Coming out of 2023-24 season, the Trust's Walks&Tours tourism operations have seen increases in visitors undertaking guided walks and slight declines in other activities, while across the board revenues grew year on year:

- Visitors on guided walks: 7125 in 2024-25 compared to 5359 in 2023-24
- Visitors on coach tours: 8502 in 2024-25 compared to 9141 in 2023-24
- Number of vintage car tours: 1255 in 2024-25 compared to 1449 in 2023-24

An exciting initiative the Trust has been working on over the past years has been monitoring our carbon footprint and operating in a sustainable and responsible manner. Since 2022, a nominal \$10 donation has been added to each vintage car tour sold and set aside for tree planting projects to offset our carbon footprint. To date 1503 native trees have been planted via our Trees That Count partners across six (6) national projects. Our 1503 trees will help to remove about 333 tonnes of carbon dioxide from our atmosphere over 50 years. In addition, this financial year, the Trust has made a \$10,000 donation to Te Mata Park to directly support their native tree planting project and keep these funds in Hawke's Bay and off set our footprint within our region.

Each year the Trust works closely with tourism industry partners to promote nationally and internationally the work of the Trust and showcase Hawke's Bay as a visitor destination. Once such partnership saw the Trust profiled on the Australian TV travel show 'Get Away', this international exposure was made possible with the support of Hawke' Bay Tourism and Tourism New Zealand. The filming took place at Craggy Range Winery.

Over the Winter months the team as participated at several Tourism conferences and tradeshows (and together with colleagues from Hawke's Bay Tourism and other local tourism businesses) outside Hawke's Bay have been sharing the message that Hawke's Bay is open for domestic and international tourists to enjoy.

Consequently, our forward bookings (pre-booked groups) look extremely positive and everyone at the Trust is looking forward to welcoming all our visitors over the months to come.

#### **Festivals and Events**

The summer Art Deco Festival Napier 2025 went off with a bang!

Over two hundred events and activities were delivered to over 19,000 unique visitors over the Festival weekend of 16-19 February 2025. Anecdotally, as reported by Napier CBD Inc, foot traffic in the Napier CBD over the 2025 Festival weekend saw a 10% increase in visitors over the 2024 Festival.

The Winter Deco Festival also proceeded as planned and again was well received by attendees. Our thanks to everyone who was involved in putting on Summer and Winter Deco weekends, with special thanks to Festival Sponsors.

#### **Operations**

The Trust is extremely grateful to Napier City Council who continue to support the Trust financially. This year we are pleased to announce the Council's continued financial support for the Trust with a new 3-year funding commitment to the continuation of the Trust's work.

Supporting operational costs, contributing to the Robert McGregor Heritage Fund, and directly supporting the Art Deco Festival. The Trust's partnership with the Council benefits the Trust with financial certainty and sustainability and the City in terms of marketing and service the Trust provides highlighting the City of Napier's special point of difference – its art deco architecture. We are very grateful to the Mayor and Councillors and the wider Napier City Council staff for the continued support we receive throughout the year from many departments and Council teams.

We are equally grateful to all our supporters – our dedicated volunteers, members, donors, sponsors, and stakeholders – who enable the Trust to deliver on our year-round purpose and commitment to the protection, preservation, promotion and celebration of our art deco era heritage. We are extremely grateful for your ongoing support.

#### Financial Reporting the year ending 31 August 2025

I am very pleased to report, less the various donations received for the restoration of the (former) Women's Rest, our Year End operational surplus is \$38,713, against a budgeted Year End surplus of \$23,416.

The surplus in the audited accounts shows a YE surplus of \$217,213, however, the surplus includes (former) Women's Rest CAPEX income of the following, which has been spend.

Lottery Grants Board: \$100,000Donations: \$55,000

Chairs' fundraising: \$23,500Total: \$178,500

This income has been spent on the fixtures and fitout of the new building, which are included in the Balance Sheet, within Fixed Assets (Leasehold Improvements, Intangibles, Office Equipment and Fixtures and Fittings).

Less the various donations and grant noted above, our year end cash surplus is \$38,713.

On our balance sheet, our year-end equity position is \$974,244.25. An increase from \$757,030.97 as of 31 August 2024.

The Board is very cognisant of our financial situation and how local and world issues could impact us at any time in the future, we therefore continue to take a conservative approach to our budgets, forecasting and cash management.

## In conclusion

I am pleased to be able to report positively on all aspects of the Trust's operations and financial sustainability this last year.

In closing, I would like to thank the staff and volunteers for their efforts during the year and for adapting to our changes in circumstances and locations. another challenging year for the Trust and my thanks to my Trust Board colleagues Rachel, Simon, Amy, Martin, Chad and Secretary Jan, and extend my thanks to Ben, who is stepping down from the Trust Board due to work commitments.

As it did in 1985 when the Art Deco Group first joined together, the Trust continues to be committed to protecting, preserving, promoting, and celebrating of our regions' unique art deco era heritage, and ensuring that the Spirit of Art Deco shines brightly into the future.

On behalf of the Board, we look forward to working with all of you, as we continue to fulfil our purpose over this coming year.
